Dear Neighbor:

Legal action must continue! THE FIGHT IS NOT OVER. You ARE impacted and we need your help. ACT NOW. Stop LAWA from destroying this community and greatly negatively impacting the region.

LAWA failed to complete the Settlement promises in the 2006 Stipulated Settlement Agreement and generated new expansion plans with more massive impacts on local communities. LAWA expansion plans include a runway movement north and west. Yet sufficient vehicle and aircraft traffic mitigations are minimal. Mayor Garcetti directed a delay to implement the runway move, but only until LAWA completes their landside projects. That's insufficient and no long-term protection for any surrounding communities. Runway expansion could be restarted without further City action. **LAWA and the City are not interested in settling the lawsuits at this time so we must progress into the expensive parts of the lawsuit and get a judgment in our favor.** LAWA is building greater landside passenger capacity not improving service or reasonable airport growth.

Lawsuits cost money. We minimize our expenses with an all-volunteer board. Only the attorneys are paid and that is still necessary. It is no consolation, but LAWA expenditures are many times that of ours. We have one of the best environmental attorneys in California working for you. ARSAC is the only one representing LA residents; Other legal team members include representatives from Inglewood, Culver City, Ontario, and SEIU-USWW.

This can impact your lives and property values. We estimate that we will need to raise \$250,000 more for legal expenses. We have raised part of this money, but we need your help to reach the goal!
